## **About this policy**

This policy explains when and why we collect personal information about our members, how we use it and how we keep it secure and your rights and relations to it.

We may collect, use and store your personal data, as described in this Data Privacy Policy and as described when we collect data from you.

We will always comply with applicable UK Data Protection legislation including GDPR when dealing with your personal data. For the purposes of the GDPR, we will be the 'controller' of all personal data we hold about you.

We have implemented generally accepted standards of technology and operational security in order to protect personal data from loss, misuse, or unauthorized alteration or destruction.

For any payments which we take from you online we will use a recognized online secure payment system.

We will notify you promptly in the event of any breach of your personal data which might expose you to serious risk.

#### Who else will have access to the information you provide us?

We may pass your personal data to third parties who are service providers or agents to us for the purposes of completing tasks and services to you on our behalf (e.g. to print newsletters and sending you mailings. However, we disclose only the personal data that is necessary for the third party to deliver the service and we have a contract in place that requires them to keep your information secure and not to use if for their own purposes.

#### How long to we keep your information?

We will hold your personal data for 21 years and will hold child protection information for 24 years.

We securely destroy all financial information once we have used it and no longer need it.

#### Your rights

You have rights under the UK data protection law, including:

- 1. To access your personal data
- 2. To be provided with information about how your personal data is processed
- 3. To have your personal data corrected
- 4. To have your personal data erased in certain circumstances
- 5. To object to or restrict how your personal data is processed.
